7.1 LEAVE RULES 7.1.1. Introduction Leave is a provision to stay away from work for genuine reasons with prior approval of the authorities. It may be granted for a casual purpose or a planned activity, on medical grounds or in extra-ordinary conditions.

Since all the State Government servants are governed by the Orissa Leave Rules, 1966 incorporated in Appendix 10 of the Orissa Service Code it is reiterated that the calculation of monthly leave salary contribution shall be 11 percent of pay drawn while in foreign service.
